**DIRECTIONS:** Thruway to exit 24, to I-87N, to Route 5 West, to Rt. 155, turn left, go 1 mile to Rifle Range Road, turn right.

### COVID-19 PROTOCOL:

- Keep at least 6 ft away from others
- Wear a face covering if tolerable when closer than 6 ft of others
- ONLY odd numbered firing points and targets to be used
- Use provided hand sanitizer upon entry and exit of pits and after using tablets or other shared items
- Report concerns to the range officer or match director

**RULES:** All NRA rules will govern this match. All matches fired at 1,000 yards using LR or LRF target. Must be NRA member for any record setting.

**Any Rifle, Any Sights (Both Days)** NRA Rule 3.2. There will be a U.S. Palma Rifle (Rule 3.3.1) and Service Rifle Class if there are 5 or more shooters (must indicate ANY or PALMA on SR-1 card).

**F-Class (Both Days):** F-Class open rule 3.4(a) [60] and F-Class TR rule 3.4(b) [61]. Please indicate if F-Class (Open or FTR) on SR-1 card.

**Range Safety Rules:** Actions must not be closed until rifle is shouldered and sights are on target! Shooters are responsible for having the correct zero for the distance to be fired. If after receiving reasonable assistance a shooter is not on target, they will not be allowed to continue firing, as directed by the match director or their designee.

**SCHEDULE:** Saturday and Sunday: 7:00AM assemble for squadding and safety brief. 7:30 AM target set-up. Each match will be fired as block time, which includes 3-minute prep period. Shooting starts at 8:00AM. Firing schedule:

#### Saturday

- Match 1: Unlimited sighters and 20 shots for record in block time of 28 minutes
- Matches 2 & 3: 2 sighters and 20 shots for record in block time of 25 minutes
- Match 4: Aggregate of matches 1, 2 and 3.

#### Sunday

- Match 5: Unlimited sighters and 20 shots for record in block time of 28 minutes
- Matches 6 & 7: 2 sighters and 20 shots for record in block time of 25 minutes
- Match 8: Aggregate of matches 5, 6 and 7. Match 9 is Grand Aggregate of matches 4 and 8.

**FEES:** Both days: \$80, Saturday or Sunday: \$45 (Preference given to both day entries). All NRA fees are already included. NO REFUNDS WILL BE GIVEN AFTER JUNE 9th.

**AWARDS:** Plaques to overall Grand Aggregate winners on Sun (Any, Palma, FO and FTR). Medals to category class winners of each match both days. Match winners are not eligible for Class awards in same match. Five or more competitors are needed to form a distinct class.

**GENERAL:** Coaching is allowed only on sighter shots. The Shot Marker electronic target system will be used. Competitors need to bring a smart phone or tablet with sufficient power for a full day of use. Competitors will be needed to assist with the set-up and take down of targets, as well as perform scoring. The paper score cards will be

the official record for the match (NRA Rule 10.17). A separate fee of \$20 (for one or both days) is to be paid to the owner of the Shot Marker system before firing commences. Those not familiar with this system should refer to the manual ([https://www.autotricker.com/uploads/6/3/4/4/63444023/11\\_-\\_shotmarker\\_manual\\_apr2020.pdf](https://www.autotricker.com/uploads/6/3/4/4/63444023/11_-_shotmarker_manual_apr2020.pdf)) and use the system during a Forbes practice day. Help will be available, but we need you to be prepared. Competitor will be responsible for paying for the replacement of any system components damaged by their shots (Sensor & block \$40, sensor cables \$10, antennae and cable \$10).

Valid entries must contain a completed SR-1 form and a check for the fees payable to Forbes Rifle and Pistol Club, Inc., and be mailed to the above address. E-mail entries not accepted. The match is limited to the first 32 entries.
