Preference will be given to shooters entering all fired matches.  
Preference will be given to shooters who did not enter the matches of July 9 and 10

FEES: Registration \$1.00 per day of which 50¢ per day to N.R.A. Bulletin to competitors. Individual Matches \$2.00; Individual aggregates \$1.00.  
Team matches \$4.00 per team, Team aggregates \$2.00 per team.

PRIZE SCHEDULE: 50% of entry fee in fired matches and aggregates in cash as follows:

MATCH WINNER: In each Match, regardless of Class, 40% of Shooters' share.  
Match Winners are not eligible for class awards in same match.

CLASS AWARDS: 60% of Shooters' share as per schedule below:  
10 or more competitors, Each Class, 1st 50%, 2nd 30%, 3rd 20%  
less than 10 Competitors, Each Class, 1st 60%, 2nd 40%  
less than 5 Competitors, Each Class, 1st 100%

MATCH 3 - Free Rifle           Any Sights

MATCH SCHEDULE JULY 31

1000 Yards 20 Shots per man, 2 man  
team, 69 minutes per team for  
sighting and record each match

MATCH 4 - Service Rifle - Issue Sights  
MATCH 5 - Any Rifle            Iron Sights  
MATCH 6 - Free Rifle           Any Sights

AGGREGATES

MATCH 7 - The aggregate of the scores fired in Matches 1, 2, & 3  
MATCH 8 - The aggregate of the team scores fired in Matches 4, 5 & 6  
MATCH 9 - The Grand Aggregate of the individual scores fired in all of the matches

TEAMS: Teams will consist of two firing members and if desired a separate coach.  
Teams will be assigned 1 target and 1 person will shoot at a time. The person not shooting may act as coach. Teams do not have to represent any organization and may be made up at the range.

SIGHTERS: 3 sighting shots will be allowed in each match, but a shooter may continue to fire sighting shots until 2 hits have been registered on the target.

ALL COMPETITORS: Are required to do pit and scoring duty for each match fired.  
During the team matches the two shooters of the team not firing will be in the pits.  
The team coach will report when his shooter has fired his sighting shots to the Range Officer. The Range Officer will relay this to the pits. Official score will be kept in the pit by the men operating the target. During the individual matches pit and scoring duty will be regulated so as to allow ample rest before firing.  
Official score will be kept on the firing line.
